



ASSUMPTION OF RISK & WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. _____ I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself, including, but no limited to; personal injury, illness, disability, death, damage, loss, claim, liability, expense of any kind, that I or my child(ren) may experience or incur in connection with attendance at Dynamic Music Studios or participation in any activities associated with Dynamic Music Studios.
